Total receipts for the month of March were \$26,034.35 and expenditures were paid for the month totaling \$10,169.55. Receipts included \$10,386 from special property tax assessments for delinquent sewer accounts.

5. PUBLIC

Pat Bollack-Brown presented a poster-size concept drawing of her proposed Lincoln funeral train mural for the north wall of the municipal building. She suggested adding text to the basic design, including possibly the names of the women who brought flowers to the funeral car and a roll call of local veterans. One goal was to present the train itself as authentically as possible. The design is preliminary and suggestions were requested. A final design will be presented for approval.

6. MAYOR'S REPORT

7. VILLAGE ADMINISTRATOR'S REPORT

Miami Valley Lighting was contacted for a quote to upgrade the street lights and maintain them. Their initial response was that their pricing would be cost prohibitive for the Village. They were asked to quote anyway. Meanwhile, DP&L will be contacted regarding the possibility of adding two Night Guard lights and to clarify what issues might be involved in future maintenance including cost.

Prescription medication take back day is planned for May 2, from 9 to 3, in North Lewisburg. The North Lewisburg Village Administrator provided posters for the event and asked that someone speak about it at this meeting. Groves stated that in the fight against heroin, prescription drugs play a significant role. The prescription drug take back program is an effective way to promote awareness of this.

It didn't reach the road and lasted about a day and a half. Flow seemed to be good. Zizzo requested the status of the drain on East Bennett. A blockage is possible. Herron to investigate.
