4. FISCAL OFFICER REPORT

Total receipts for the month of December were \$19,706.46 and expenditures were paid for the month totaling \$71,056.50. Receipts included a dividend from BWC of about \$1,900 and \$223 from the sale of scrap metal from unrepairable pumps. Expenditures included about \$20,000 for the pole project, \$500 for the meeting room cabinet for coronavirus supplies, \$900 for the in-line UV disinfecting unit in the HVAC system, \$2,850 to Crane to repair a lift station pump, and \$30,000 for the portable message signs for coronavirus communications. Herron will

discuss the signs later in the meeting. About \$1,100 remained in the coronavirus fund at year end. This carryover wasn't included in the temporary appropriations budget passed in December because, at the time, the ability to spend it was to expire Dec. 30. An ordinance reestablishing the fund in the temporary budget will be considered later in the meeting. Garland moved and seconded by Morgan to accept the financial statements for December 2020 and approve December 2020 expenditures as presented by the Fiscal Officer. Weidner asked about the possibility of building our own treatment plant. Herron stated that he thought the annual cost would exceed the cost of continuing with a contract, and that he would confirm that.
