5. MAYOR'S REPORT

A vacancy on Council has again opened up due to Jody Riegler's move from the Village.

ODOT has proposed a network of designated bicycle routes throughout the State. These routes link to a national network. East and West Bennett through the Village are part of the proposal. The white base coat needs to be completed as well. Herron stated that a painting contractor he found would be able to start work on the base coat in September.
